Preliminary Medical Testing

Prior to processing your Stage One payment, we place significant emphasis on the completion of preliminary testing requisites. Primarily, they offer a detailed overview of your reproductive health, ensuring its compatibility and readiness for the intricate process of in vitro fertilization. Beyond this, these evaluations play a crucial

role in upholding the highest standards of health and safety for our dedicated surrogates. We are committed to ensuring that every aspect of the process, from initiation to completion, is rooted in careful consideration for all involved parties, and these tests are a testament to that commitment.



Female Fertility Tests

- **Vaginal Ultrasound:** This test is performed from the 2nd or 3rd day of the menstrual cycle and is used to assess the follicles in the ovaries.
- **FSH, LH, E2, and P4 Levels:** Blood tests measuring follicle-stimulating hormone (FSH), luteinizing hormone (LH), estradiol (E2), and progesterone (P4) levels. These tests are typically done from the 2nd or 3rd day of the menstrual cycle and help evaluate ovarian function and hormone levels.
- **AMH Levels:** Blood test to measure anti-Müllerian hormone (AMH) levels. This test can be done at any time and provides an indication of ovarian reserve.
- **Thyroid Panel:** Thyroxine (T4) Free, Direct; TSH; Thyroxine (T4); Triiodothyronine (T3); Thyroid Peroxidase (TPO) Ab; Triiodothyronine (T3) , Free



Male Fertility Tests

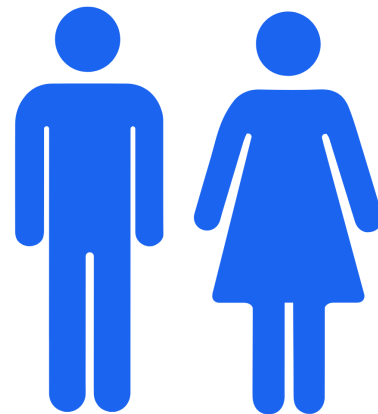
A **sperm analysis**, also known as a seminogram or semen analysis, is a laboratory test performed to evaluate the quality and health of a man's sperm. It provides important information about the sperm count, motility (movement), morphology (shape), and other characteristics that are essential for fertility.

Key Parameters:

- Sperm Count
- Sperm Motility
- Sperm Morphology
- Semen Volume
- pH Level

For Best Results:

- **Abstain from sexual activity:** It is recommended to abstain from ejaculation for 2 to 5 days before providing the sample.
- **Stay hydrated:** Proper hydration is important for overall health and sperm production.
- **Maintain a healthy lifestyle:** Follow a balanced diet.



STD Panels

- **HIV (Human Immunodeficiency Virus):** This test checks for the presence of HIV antibodies or antigens.
- **Hepatitis B surface antigen (HBsAg)** test is used to detect the presence of a protein called the surface antigen of the hepatitis B virus (HBV) in the blood. The test is primarily used to diagnose current or acute hepatitis B infection.
- **Hepatitis B core antibody (anti-HBc):** This test detects antibodies against the core antigen of the hepatitis B virus and can indicate a past or ongoing infection.
- **Hepatitis B surface antibody (anti-HBs):** This test detects antibodies against the surface antigen of the hepatitis B virus and indicates immunity to the virus, either through vaccination or past infection.
- **Hepatitis C (HCV):** This test detects the presence of antibodies produced by the body in response to a Hepatitis C infection.
- **Syphilis:** This test helps identify the presence of the bacteria *Treponema pallidum*, which causes syphilis.

Surrogacy Program with Egg Donor

For individuals or couples in need of an egg donor, our “Surrogacy Program with Egg Donor” is the ideal option. We encourage you to explore our egg donor database and select your preferred candidates. We will then inform you of their availability and specify whether they have pre-stored frozen eggs or require a retrieval.



Accessing Our Egg Donor Database

Our egg donor database can be accessed through the Kira Client App at kiraclient.com. After logging in, you'll find the database under the “Resources” tab.



Only Male Fertility Testing Required

Given that your egg donor has already undergone the necessary female fertility tests, only the male fertility tests and STD panel will be required for your program's initial screening.



Frozen Eggs vs. Retrievals

Frozen Eggs and Egg Retrievals each come with their own sets of advantages and drawbacks. Utilizing frozen eggs provides the certainty of knowing the exact number of eggs you will be starting with, ensuring no surprises in that initial phase. On the other hand, while egg retrieval doesn't offer that precise initial count, it holds the potential advantage of yielding a significant number of eggs. This might result in a higher number of viable embryos, increasing the chances of a successful implantation. Both methods have their merits, and the choice will depend on individual preferences and specific circumstances.

Upon finalizing your decision to transport your embryos to our clinic, we will promptly provide you with a comprehensive transport checklist. This checklist is expertly crafted to detail every piece of information and documentation we require from your current clinic to ensure a seamless transition and medical approval. This will encompass STD panels for all intended parents or, if applicable, the egg donor, as well as an in-depth embryology report. It's crucial for us to understand the techniques your clinic employed for freezing the embryos, alongside the protocols they recommend for their subsequent thawing. This ensures optimal care and increases the chances of successful implantation. Once we've thoroughly reviewed and have in hand all the essential documentation, we will initiate the careful and secure process of transporting your embryos to our facility.



Shipping Options

Our agency partners with a specialized shipping company that we have entrusted with the transportation of embryos for many years, successfully managing shipments from The United States, Canada, and Australia. This company boasts a flawless track record with a 100% success rate in deliveries. Nonetheless, we respect our clients' autonomy, and you are certainly welcome to select a shipping service of your preference. Please note, for the safety and security of the embryos, we mandate that any chosen shipping provider delivers directly to our clinic's premises. Unfortunately, due to stringent liability considerations, we cannot facilitate the collection of embryos from the airport or any other off-site location in Guadalajara.

Unlike our other two programs, you are required to complete the female fertility testing before proceeding with your Stage One payment. The necessary tests can be found on the Preliminary Testing page, page 7.



Male Fertility Testing Required

For your program's initial screening, both the male fertility tests and the STD panel are necessary. Please refer to the Preliminary Testing section on page 7 for the detailed requirements.



Planning For Your Two Week Stay

If you're considering using your own eggs for the procedure, it's essential to budget for a two-week stay in Guadalajara. This period is crucial to ensure a successful egg retrieval process. Initially, a stimulation period is required, during which specific medications are administered to encourage the maturation of multiple eggs. Following this phase, the actual retrieval takes place, where the matured eggs are carefully extracted.
